Given its mission, Imagine Our Florida has adopted a code of ethics to guide its Board members, committee members, staff and volunteers in their conduct when acting on behalf of Imagine Our Florida. The Code contains broad principles reflecting the behavior Imagine Our Florida expects towards constituents, donors, employees, peers and the public.

CODE OF ETHICS:

We will:

1. Comply with applicable federal, state and local laws in all of our operations
2. Respect the confidentiality of sensitive information about Imagine Our Florida, its members, constituents, donors, Board, and employees
3. Make an effort to understand, respect and support our constituents from other cultures, exemplified by the contributions of our staff and executive leadership, and to contribute to an organizational culture that respects the diverse, individual contributions of staff and leadership
4. Refrain from conduct endangering the life, safety, health or well-being of ourselves and others - this is strictly prohibited and this item will be strictly enforced
5. Act at all times in accordance with the highest ethical standards and in the best interest of Imagine Our Florida, its members, constituents, donors and reputation
6. Maintain transparency and honesty in our fundraising activities or in prospecting for new members to join Imagine Our Florida
7. Appropriately acknowledge contributions from other individuals and organizations who contribute to facilitating our goals
8. Honor our commitments and promises to the best of our abilities
9. Avoid and report all conflicts of interest that could harm or jeopardize the efforts, procedures, interests, and reputation of Imagine Our Florida and its entities
10. Report any observation or knowledge of violations of these standards, or a violation of the law, or direct questions about the meaning, intent, and/or application of these standards to Organization Leadership promptly; This Organization will not tolerate any reprisal or retaliation or suspected violation of these standards or the Law.
11. Make significant efforts to resolve any dispute amicably and in the spirit of trust, respect, and fairness
12. If any employee or volunteer fails to comply with this Code of Ethics, that person may be put on notice or terminated, in the discretion of the Chief Executive Officer or the Board of Directors of Imagine Our Florida.

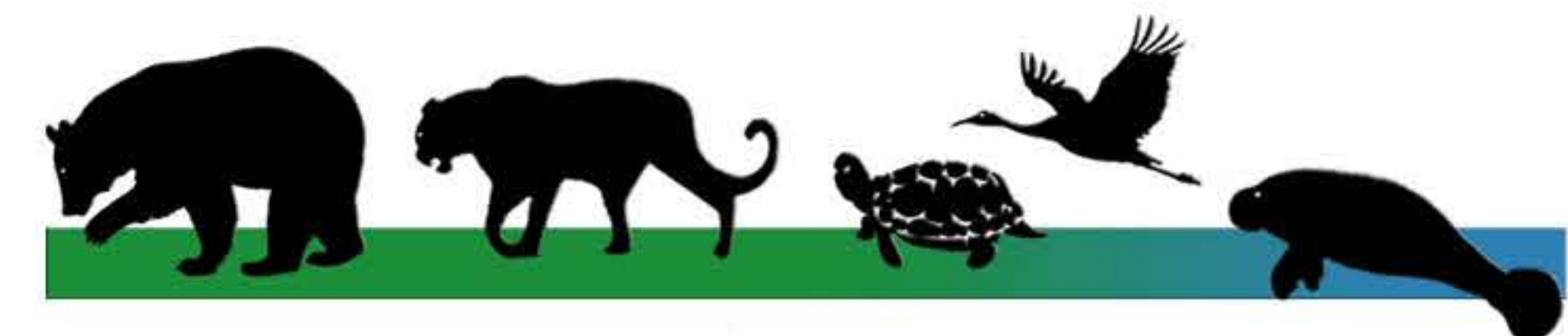

EVENT RULES:

The purpose of IOF events is to educate people how to make their voices heard. We may provide them with the opportunities to sign petitions, contact information to write letters and emails, and/or contact information to call or visit their legislators or appropriate agencies.

RULES:

1. Follow all rules set forth by the Venue Coordinator
2. At least 2 people must be tabling together.
3. Be courteous.
4. Address only the causes you have printed materials for.
5. State facts, not opinions.
6. Name only those who have done good things. Do not name those whom we oppose.
7. If confronted by someone with opposing views, take the high road and back down.
8. Speak to every guest as if a child, or your grandmother, is standing next to you.
10. Do not leave your table to canvass the crowd.
11. IOF is a 501(c)(3) non profit organization. Contributions are tax deductible.
12. Imagine Our Florida's Code of Ethic applies when you are representing the Organization. Report any violation to the Board of Directors.
13. All activities and fundraising must be approved. The Board of Directors' decision is final.
14. Do not leave donations, signatures or volunteer information unattended. If the event lasts more than one day, take these items home with you at the end of each day. Send donations, signatures and sign up sheets to the designated contacts.
15. Be sure to Thank the Venue Coordinator for allowing us to be a part of their event.
